Mayor Carroll moved to adjourn the meeting at 10:37 P.M.; Councilmember Vick seconded the motion, which was carried unanimously.

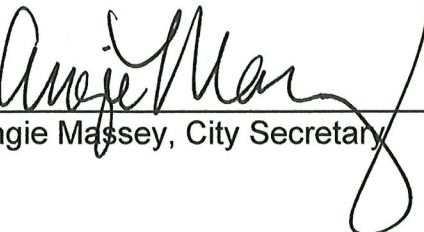
