1. CALL TO ORDER

Mayor Proud called the meeting to order at 9:05 A.M. Attendees: Mayor Proud, Councilmember Khait, Councilmember Mycoskie.

Deputy Gonzalez discussed with the council the report for the month of October 2025.

B. Parks and Recreation Liaison

Councilmember Khait stated that the Park and Recreation had a meeting the previous day. They discussed the event set for December 6th, Santa back at the Park. They discussed maintenance of the woodchips for the playground. Water fountain estimates for installation were requested.

C. POA Liaison

City Administrator stated that the POA talked about wooden fences and working with residents to get this accomplished. Emergency Keypads are being installed this week. The POA is moving to the small conference room this week. Their finances are in good shape. They have selected a new management company; more details will be shared soon.

D. MUD Liaison

City Administrator stated they discussed water rates, salary increases, cold weather safety, and precautions for working in cold weather. Budget is on track. They started receiving property tax payments.

E. WC Liaison

Councilmember Khait stated that they had met on Tuesday, October 21st, followed by a happy hour. Two couples and a few singles attended the happy hour. New residents gave positive feedback about the welcome and introduction to the community. Forty-one of forty-six new properties have been contacted since May.

F. City Administrator

City Administrator stated that the city has been dealing with enforcement of property issues, such as pool drainage, trash, etc. Some residents have been evicted and have to deal with residents removing their items from the yard after evictions. I have also worked with Constable Gonzales on the e-bike situation, which has migrated into Flintrock Community as well as The Hills.
